In the summer of 1895 E.S. Smock and Fred G. Blakey were appointed by brethren interested in the matter to solicit subscriptions to a fund for building a Church of Christ at the village of Maud in Shelby Co., Mo. They were so successful that a building committee consisting of Bros. John Daniel, Pleasant Daniel, Joseph Steward, and Wm. F. Miller was appointed and an elegant frame building was erected in the summer of 1896.

Oct. 19th Bro. George W. Buckner began a protracted meeting continuing three weeks and resulting in 48 confessions, four reclaimed and two uniting with us from the Baptists and one from the Methodists.

The house was dedicated Oct. 25th and a congregation organized Oct. 31st with seventy six members the number increasing during the meeting to 96.

Brothers John Daniel, Wm. Taylor, Edward Smock and Thos. H. Phillips were its first elders and F.M. Dale, Jas. Bryan, Robinson Hanger, and Fred G. Blakey deacons and John Daniel Treasurer and F.G. Blakey Clk.

Bro. Clinton Lockhart President of Christian University Canton, Mo was its first pastor and filled the pulpit one year and was succeeded by Bro. A.B. Elliott of Kirksville Mo. Who remained three years and was followed by Bro. J.W. Davis of Kirksville, Mo. Who remained five years, and was followed by Clements of Canton who remained Eight Months and resigned, the first Sunday in April 1904 was followed by Brother Allen C. Hitch who made us four visits from Canton was drowned near Canton July 7, 1904. Who was followed by Bro H.D. Williams of Canton who remained the rest of that year. Who was followed by J.B. Weldon of Canton Jan 1905 who remained one year, and was followed by C. V. Pierce of Canton in Feb 1906. Who rema the balance of year and was followed by J.M. Harris of Callao in July 1907 who remained with us untill the close of the year 1908. Who was followed in February 1909 by C. W. Wordon of Clarence.

In the Fall of 1923 O.E. Hamilton Held 7 day Meeting with 39. aditions. Bro C.E. Nichols was Pastor. In the Fall of 1924 Arthor Long Held 7 days Meeting with 6. adition Bro C.E. Nichols Pastor.

Mr. Hammett volunteered to give the logs and deliver them at the mill. Mr. Naylor & son Charley agrees to put house up. Mr. O C. Davis and Fre Heathman agrees to pay for sawing of the logs. Mr. Dale agrees to haul lumber and furnish padlock on house. Mr. Davis offered his resignation as treasurer on account of being so far from Church. Resignation was accepted. Motion and sec that Fred Heathman act as treasure. Fred not wanting to act. Mr. Hammett (?) was nominated and reserved 9 votes Fred 1.

Motion wheather we get some one to help in meating...left to see Bro Weldon in reguard but agree to get some good man to help in meeting.

Bros Edd Smock, J.C. Bilbro and C.R. Bishop were nominated for Deacons for respectable 3-2-1 yr & Elected. Bros O.C. Davis, George Ridgway and John Phillips were nominated for Deacons for a term of yrs Respectable 3-2-1 yrs.
